Detective John Garvey, shield 07765 of the 026 Detective Squad, states as follows:

On January 2, 2004, at about 10:30 hours at 3009 Broadway in the County and State of New York, the Defendant committed the offenses of:

1. PL240.30(1) Aggravated Harassment in the Second Degree
(2 counts)

the defendant, with intent to harass, annoy, threaten and alarm another person, communicated and caused to be communicated by mechanical or electronic means in a manner, with a person, by telephone, mail or any other form of written communication, in a manner likely to cause annoyance and alarm.

The offenses were committed under the following circumstances:

Deponent states that informant Robert Pollack deponent was forwarded an e-mail from Ron Prywes that the defendant had originally sent, dated January 2, 4:59PM that stated in part and in substance: **ROBERT POLLACK SPECIALIZES IN OPPRESSING AND HARASSING FOREIGNERS AT COLUMBIA. HE IS A TOTALITARIAN. HE WAS SECRETLY FIRED FROM COLUMBIA FOR DOING DECEIT AND OTHER WRONGDOINGS.** Deponent is further informed by informant Pollack that the defendant's electronic mail harassed, annoyed, alarmed, and frightened informant Pollack.

Deponent states that deponent is informed by Michael Feiekman, Counsel for Barnard College, that the defendant sent an electronic mail to informant stating in substance on January 2, 2004 at 10:30AM: **KAREN BLANK WILL INVOLUNTARILY DEPART BARNARD IN 2004, NEVER TO RETURN.** Deponent sent a total of 13 e-mails to others at Barnard College, that stated the same in substance, starting on January 2, 2004 continuing through January 9, 2004. Deponent is informed that informant Feiekman was annoyed, alarmed, and harassed by this e-mail.
